

- c) To establish orphanages, boarding and lodging houses for students.
- d) To institute awards, Scholarship in India for study research and apprenticeship and for helping poor students.
- e) To receive or accept donations in cash or properties to augment the trust fund and to carry out the objects of the trust by such donation without being subject to any control in the selection of the trustees or the management by the trustees as incidental to such donations.



- f) To provide food, shelter, clothing medical care and education for the poor and down trodden people.
- g) To afford relief of people in distress due to natural calamities.
- h) To grant the donation for support of other needy public charitable institutions.
- i) To carry on community development programme for the development of the socially and economically weaker section.
- j) In furtherance of the objects to purchase and acquire immovable properties and movable properties, to enter into lease or rent or agreement if necessary to sell or encumber properties for the benefit of the trust which shall be in the absolute discretion of the trustees and to demolish and reconstruct buildings or to renovate buildings as and when necessary arises.
- k) To do such other things as are conducive to the advancement of the above objects.

4. TRUST FUND:- It shall comprise properties and assets hereinafter following:-

- a) The sum of Rs. 1000/- (One thousand only) contributed by the founder of the Trust.
- b) Properties and assets including cash that may be contributed by the founder of the trust hereafter.
- c) Properties movable or immovable which the trust may receive as donations and subscriptions to augment the trust fund without any condition relating to the management of the trust.
- d) The income of the trust from properties and assets of the trust and from the invested funds of the trust.

e) The funds of the trust will be invested only in such manner as prescribed under section 11(3) of the Income tax Act 1951.

5. MANAGEMENT:-

- a) The management of the affairs of the trust shall rest in a board of trustees. The board shall have all the powers incidental to and necessary for carrying out the administration of the trust having regard to the objects and purposes thereof.
- b) The board shall function in accordance with decision of the majority of the members of the board. Such decision may be arrived at in meeting of the board or by circulation. In the event of a tie the founder trustee shall have in addition arrived at a meeting of the board. If opinion is a casting vote. In case decision is equally divided on circulation the founder trustee will have the right to decide in favour or against the proposal dealt with in circulation.
- c) The board of Trustees shall consist of the founder and other members nominated by the founder. The number of members of the board other than the founder trustee will be in accordance with what can be decided by the founder according to his discretion. Subject to the condition that the total number of trustees shall be not less than three and not more than nine. In the matter of selection of the board of trustees the founder will have regard to the suitability of the person to be nominated to the board having regard to the object and purpose of the trust.

it necessary for facilitating of the management of the trust.

- 1) The founder trustee shall be the chairman of the Board of Trustees. He will preside over meetings of the Board.


In his absence the meeting of the board may function with somebody among them elected or selected as chairman for the meeting. The trust had been started from 30th August 1988.

- 2) The quorum for board meeting shall be not less than five.
- 3) If any vacancy arises in the board by death, resignation or disability or supervening the founder shall have the right to make substitution. The founder trustee is not bound to appoint anybody by way of substitution. That is left to his discretion.
- 4) In case the founder's seat falls vacant is shall get filled up according to the decision of the board of Trustees.
- 5) The founder trustee shall be the managing trustee. He has the right, power and duty to carry out the day-to-day administration of the trust. He has also the power of the management of the affairs of the trust for union behalf of the Board of Trustees.

6. FINANCE:-

- a) The Board of Trustees shall have the discretion and power to make necessary investments of trust funds in the best interest of the trust.



- b) Bank accounts may be opened in the name of the trust. The accounts shall be operated by the founder trustee and financial Trustee or whichever will succeed him and financial trustee.
- c) Proper books of accounts shall be maintained in the trust. They shall be audited by a Chartered Accountant. The financial year for the trust shall be the year ending on 31st March.
- d) The Board may frame rules byelaws or regulations regarding the administration and management of the trust as also regarding duties and responsibilities for carrying out the objects of the trust. The appointment of committees, sub-committees their duties and obligations and other matters connected with or relevant to the trust and its administration.
- e) The Board of Trustees has the powers to convert, to call in, to sell or otherwise dispose of or dispense with any of the investments, all or deal with movable and immovable properties of the trust and re-invest or change the nature of investments.
- f) The Board shall have the powers to borrow monies and raise loans either by mortgaging the trust properties or otherwise for the purpose of carrying out the objects of the trust.

7. CUSTODY OF DOCUMENTS:-

The founder trustee or his nominees or the successor of the founder trustee or his nominee as the case may be shall have the custody of all the documents and deeds of title relating to the trust and its properties and shall be responsible for the preservation of such documents and deeds.

8. ADVISORY BODY & COMMITTEE:-

- a) The Board of Trustees may appoint experts and advisers and secure their services and advice to further the objects of the trust and incur necessary expenditure therefor.
- b) The Board of Trustees may appoint committee or committees and entrust with them powers to execute or administer the projects that may have been undertaken by the Board while carrying out the object of the trust. The Board may incur necessary expenses therefor.

9. GENERAL:

- a) The Board shall have power to do everything necessary to implement the objects of the trust and will have the incidental powers to effectively administer the affairs of the trust.
- b) The Board of trustees shall have the powers to make and alter or amend the rules and regulations made with regard to the conduct of the affairs of the trust as and when necessary.
- c) The trust is irrevocable. The income of the trust shall be solely devoted to meet and implement the objects of the trust in other words the trust funds shall be utilised only for public charitable purposes. Expenses made shall have ultimate relation to a charitable purpose.
- d) If the trust fails for any reason the net assets of the trust shall be handed over to any other charitable trust having the same or similar object, as may be decided by the Board of Trustees.


